SECOND AFFIDAVIT OF AARON MOSS

I, **Aaron Moss**, of the City of Cambridge, in the Regional Municipality of Waterloo,

AFFIRM:

1. I am the Director of Facilities and Fleet at the Region of Waterloo (the “**Region**”). As such, I have personal knowledge of the matters set out in this affidavit. Where I do not have personal knowledge of a matter, I state the source of my information and believe it to be true.

2. In this affidavit I will use terms as defined in my previous affidavit (affirmed January 16, 2026) offered in support of the Region’s Application (the “**1st Moss Affidavit**”).

3. I attach as **Exhibits “A”, “B”, and “C”** to this affidavit status reports for 100 Vic prepared by the Region’s security team for the periods from March 16 to 22, March 23 to 29, and March 30 to April 5, 2026, respectively. As explained below, these reports reflect there being 16 structures at the Encampment (9 of which were occupied) as of March 23,

20 structures (15 of which were occupied) as of March 30, and 22 structures (14 of which were occupied) as of April 6.

4. Exhibits “A”, “B”, and “C” (collectively, the “**Reports**”) are compiled by members of the Region’s security team in the ordinary course of their duties. Security is onsite at the Property every day. The Reports reflect data and information observed and collected by the Region’s employees or contractors in the ordinary course of their duties. The number of total and occupied structures observed at the Encampment set out in the Reports reflects the count as conducted the day after the weekly incident summary period ends. These counts are conducted and reported by the Region’s mobile security supervisors who undertake and record this count in the ordinary course of their duties based on their firsthand observation at the Property.

5. The Reports also detail contemporaneous accounts of various security incidents that occurred at 100 Vic during the applicable time periods that have been aggregated into one document. I have redacted mention of these incidents from the attached Reports.

6. In the 1st Moss Affidavit at paragraphs 37-39 I provided an update on numbers at the Encampment based on information provided to me by Ryan Pettipiere. I understand that these numbers came from USWs, who also track and report these numbers in the ordinary course of their work.

7. I personally attended the Property (accompanied by security) on April 8, 2026 at approximately 11:15 am. While I was at the Encampment, I counted 20 structures onsite. While onsite I observed only one person at the Encampment. I observed smoke coming from three structures, from which I inferred that an individual was present within these

structures. Based on the state of the structures I did observe, I have no reason to doubt that the 9-15 occupied structure range as reflected in the Reports is correct.
